

## NETS Service(s) Application Terms and Conditions

### [For Private Sector Only]

- a) We hereby apply to participate in the above selected service(s) and agree to give 1 month's prior notice in writing to NETS should we wish to discontinue the service. We agree to execute and abide by the terms and conditions as stipulated in the Service Provider Agreement and such amendments thereto as NETS may stipulate from time to time.
- b) We agree to pay NETS a termination fee of S\$30.00 per terminal if we (i) withdraw or cancel this application for whatsoever reason, or (ii) terminate our use of the service before the expiry of six (6) months from the date of approval of this application. NETS shall be entitled to debit the amount from our designated bank account without further notice to us.
- c) In the event of termination of the Service Provider Agreement, we agree to pay NETS all fees up to the date of termination or the date we return the terminals to NETS, whichever date is the later.
- d) **For New Merchant with NETS and/or NETS FlashPay Services Only**
