



## Terms and Conditions of the NETS POS Subscription Fee Waiver Online Promotion

The NETS POS Subscription Fee Waiver Online Promotion ("Promotion") is carried out by Network for Electronic Transfers (Singapore) Pte Ltd ("NETS") and is subject to these terms and conditions ("Terms").

1. The Promotion is open to new-to-NETS merchants, who are currently not registered in NETS' database ("New NETS Merchant") and apply online for a NETS POS terminal for the first time to enjoy a 3-month waiver of monthly NETS POS Subscription Fee.
2. The Promotion is valid for eligible online NETS POS applications from 1 July 2021 to 31 December 2021 ("Promotion Period").
3. To be eligible for the promotion, online application has to be made through one of the following links:

5. The online application is considered successful upon approval from NETS within the Promotion Period. The New NETS Merchant must also collect the terminal(s) within 2 weeks from the application approval date to enjoy the Promotion.
6. The monthly NETS POS Subscription Fee of \$38 will be waived for the first 3 consecutive months, commencing from the date of collection of terminal(s). Monthly subscription fees will apply from the start of the fourth month.
