



Terms & Conditions of Food Republic x NETS Lucky Draw (1st September – 30th November 2021)

The Food Republic x NETS Lucky Draw campaign ("**Lucky Draw**") is carried out by Network for Electronic Transfers (Singapore) Pte Ltd ("**NETS**") and is subject to these terms and conditions ("**Terms**").

1. The Lucky Draw is open to all existing DBS/POSB, HSBC, OCBC, Maybank, Standard Chartered, UOB ("**Participating Banks**") and NETS bank cardholders ("**Customers**"), including the employees of NETS and employees of the aforementioned six (6) Participating Banks.
2. The Lucky Draw campaign period is from 1st September – 30th November 2021 ("**Campaign Period**").

4. DBS-NETS/ POSB-NETS/ HSBC-NETS/ OCBC-NETS/ Maybank-NETS/ Standard Chartered-NETS/ UOB-NETS ATM, debit and credit cards issued by the Participating Banks in Singapore shall be "**Qualified NETS Bank Cards**" that may be used by a customer to participate in the Lucky Draw
5. QR code payments made only via Participating Bank Mobile Applications (including NETSPay, DBS PayLah, DBS digibank mobile app, POSB digibank mobile app, UOB Mighty, OCBC PayAnyone and Standard Chartered Mobile Banking App) may qualify for participation in the Lucky Draw ("**Qualified QR Code Payments**").
6. NETS may from time to time in its absolute discretion decide on the eligibility of a Participating Merchant or Customer for participation in the Lucky Draw.

Lucky Draw Mechanics:

7. Customers are automatically entered into the Lucky Draw when every minimum spend of S\$6/- in a single receipt/transaction is made with their Qualified NETS Bank Cards or Qualified QR code payments at any one of the Participating Merchants in Singapore during the Campaign Period ("**Qualifying Transaction**"). Customers may opt-out of the Lucky Draw by sending an email before 30th November 2021 to marketing@nets.com.sg, stating your name, email address, contact number, bank name and your statement that you wish to opt-out of this Lucky Draw.
8. Customers will receive one (1) chance in the Lucky Draw with every Qualifying Transaction.
9. There will be 71 winners drawn for cash reward ("**Prize**"):-
 - a. Grand Prize: \$6,800x 1 winner
 - b. Second Prize:\$2,800 x 1 winner

10. Each winner can only win a Prize once. For the avoidance of doubt, if a Customer is drawn more than once to win a Prize for multiple Qualifying Transactions made, he or she will not be entitled to the subsequent Prizes drawn.
 11. The draw will be conducted on NETS' premises on 8th December 2021.
 12. The names of the winners will be publicly published on the NETS website (www.nets.com.sg) by 10th January 2022.
 13. Upon the successful verification by NETS and subject to the winner's compliance with any instructions specified by NETS, winners will receive the Prize via a bank transfer no more than three (3) months from date of draw.

The qualified transaction account with respective bank that are eligible for this "Food Republic x NETS Lucky Draw" campaign must not be blocked for use (in good standing) and conducted in a proper and satisfactory manner as determined by the banks in their sole discretion at the time of crediting the cash reward. In the event that the registered card and/or account is delinquent, voluntarily or involuntarily closed or terminated or blocked for use for any reason whatsoever before the cash reward is credited into the said account, NETS and/or the participating banks reserve the right not to credit the cash reward to the Participant.
 15. Reserve winner(s) will be drawn to replace any winner(s) subsequently disqualified and will receive the Prize via a bank transfer no more than three (3) months from date of draw.
 16. Winners shall comply with any instructions specified by NETS or the Participating Banks. In the event a winner fails to comply with any other instruction or condition specified by NETS or the Participating Banks, the Prize may be forfeited at NETS' absolute discretion.
 17. Prizes are not transferable, exchangeable nor redeemable for other prizes.
 18. In the event that the Prize incurs any tax liability, such tax is the sole responsibility of the winner.

By participating in this Lucky Draw, each participant is hereby deemed to have consented and agreed to each of the Participating Banks sharing, disclosing and/or releasing their names, contact information (e.g. mobile number, email address and mailing address), and transaction history to NETS for the purpose of facilitating this Lucky Draw, announcing the winners on NETS website, for the fulfilment and redemption of the Prizes and for the submission of an audited statement of account of the Lucky Draw to the Singapore Police Force under the Common Gaming (Exemption) Notification 1997 / Remote Gambling (Exempt Persons) Order 2015.

20. Winners of the Lucky Draw will be notified by NETS and/or the Participating Banks via call / SMS / email / redemption letter within one (1) month of the Draw Date.

NETS reserves the right to disqualify an otherwise eligible Customer from winning a Prize and/or substitute another Customer as the winner in the event that NETS in its absolute discretion believes that the particular Customer may have contravened, will contravene or has contravened any of these Terms and/or may bring NETS into disrepute. In the event the Prize has already been awarded to such a Customer, the Prize must be returned to NETS at the Customer's cost and expense.
22. NETS reserves the right to substitute the Prize with another prize of lower or equivalent value, whether of similar nature or otherwise without prior notice.
23. NETS reserves the right to partially or completely cancel, terminate or suspend the Lucky Draw for any reason without any liability whatsoever.
24. NETS' decisions on all matters pertaining to the Lucky Draw are final and binding. No further correspondence regarding the Lucky Draw, these Terms or any decision made by NETS in connection therewith and/or the results will be entertained. NETS reserves its absolute right to determine an outcome and act as it deems fit in any dispute and/or issues relating thereto.
25. NETS or the Participating Banks shall not be liable to any person in any way for any loss or damage howsoever arising from or in connection with the Lucky Draw and/or any of the Prizes.
26. NETS reserves the right at any time to amend or delete these Terms and/or any of the instructions or explanations at its sole discretion without prior notice. Any such changes shall be binding and will take effect immediately upon such amendment, change or deletion. Participation in this Lucky Draw shall constitute acceptance of these Terms and any amendment(s) thereof.
