



Terms & Conditions of NETS Spend & Redeem at Gardens by the Bay and Mediacorp National Day Concert 2026 (2 August 2026)

The NETS Spend & Redeem at Gardens by the Bay and Mediacorp National Day Concert 2025 (“**Promotion**”) is organised by Network for Electronic Transfers (Singapore) Pte Ltd (“**NETS**”).

The Promotion period is valid on 2 August 2026, (“**Promotion Period**”) unless otherwise stated.

1. Eligibility:

- i. The Promotion is open to all visitors who make qualifying purchases at participating stalls at Gardens by the Bay and Mediacorp National Day Concert 2025.

2. How to Participate:

- i. Participants must spend a minimum of \$15 via any NETS Payment Mode (defined below) within a maximum of 2 receipts from purchases made on the same day, to qualify for the Promotion (“**Qualifying Transaction**”).
- ii. Receipts must be dated within the same day of redemption and from participating stalls at Gardens by the Bay and Mediacorp National Day Concert 2026.
- iii. Only original printed receipts are accepted. Duplicates, photocopies, digital photos/images of receipts or handwritten receipts will not be eligible.

3. Redemption Process:

- i. Participants must visit the Redemption Booth located at The Meadow, Gardens by the Bay and Mediacorp National Day Concert 2026 to submit their receipts and furnish the required information.
- ii. Each eligible participant produces (i) the physical receipt (maximum of two combined receipts) evidencing the Qualifying Transaction at Redemption Booth and/or (ii) a screenshot or image evidencing the Qualifying Transaction made using any NETS Payment Mode (defined below) at Redemption Booth (“**Proof of Payment**”).
- iii. The Redemption Booth will operate from 4.30 PM to 9:00 PM daily during the event.
- iv. Redemption of limited-edition NETS FlashPay card is limited to the first 250 redemptions per day. Redemption is on a first-come first-served basis, while stocks last.

4. Promotion Rewards:

- i. Upon successful verification, participants who spend a minimum spend of \$15 will receive a limited-edition NETS FlashPay card, while stocks last.
- ii. “**NETS Payment Mode**” shall mean the following:
