



General Terms & Conditions of the HDB Malls Lunar New Year Lucky Draw 2025

Lucky Draw Period

- Participant will be required to present NETS receipts of their mall spendings for verification to redeem a lucky draw ticket.

Participation in the Lucky Draw

- Max 3 combined NETS receipts from shops OR 1 single NETS receipt from supermarkets.
- The Management and its appointed organiser reserve the right to turn away any customer/shopper without reason or prior notice.

Conduct of Lucky Draw

- The lucky draw will be held at participating HDB Malls. Please refer to the schedule for mall locations and the date/time.
- The lucky draw will be held in the same mall where the ticket is issued.

- For instalment plans, only one redemption is allowed for the total purchase amount.
