Terms & Conditions of Pay with NETS and be rewarded at Bata and Jollibee promotion (1 December 2024 – 31 January 2025)

The Pay with NETS and be rewarded at Bata and Jollibee (“**Promotion**”) is carried out by Network for Electronic Transfers (Singapore) Pte Ltd (“**NETS**”) and is subject to these terms and conditions (“**Terms**”).

1. The Promotion is open to all existing DBS/POSB, HSBC, OCBC, Maybank, Standard Chartered, UOB (“**Participating Banks**”) and NETS bank cardholders, including the employees of NETS and employees of the Participating Banks (collectively referred to as “**Customers**”).
2. The Promotion period is valid from 1 December 2024 – 31 January 2025, both dates inclusive (“**Promotion Period**”) unless otherwise stated.
3. The Promotion is valid at selected Bata outlets and selected Jollibee outlets in Singapore which are registered with NETS and/or the Participating Banks and accepts payment through Qualified NETS Bank Card and/or Qualified QR Applications (defined below). 4. NETS may from time to time in its absolute discretion decide on the eligibility of a Participating Outlets or Customer for participation in the Promotion.
5. For the purposes of this Terms:
 - a. “**Qualified NETS Bank Cards**” shall mean DBS-NETS/ POSB-NETS/ HSBC-NETS/ OCBC-NETS/ Maybank-NETS/ Standard Chartered-NETS/ UOB-NETS ATM, debit and credit cards issued by the Participating Banks, NETS FlashPay and NETS Prepaid Card in Singapore; and
 - b. “**Qualified QR Applications**” shall mean the Participating Banks’ QR payments mobile applications (which include NETSPay, DBS PayLah, DBS digibank mobile app, POSB digibank mobile app, UOB TMRW, OCBC Pay Anyone™, OCBC Digital and Standard Chartered Mobile Banking App)

Customers are eligible to receive a Jollibee voucher (“**Jollibee Voucher**”) (1 piece) if he/she spends a minimum of \$50 in a single receipt at the selected BATA’s Participating Outlets using their Qualified NETS Bank Cards or Qualified QR Applications during the Promotion Period (“**BATA Qualifying Transaction**”).
7. Jollibee Vouchers are limited to the first 7,500 BATA Qualifying Transactions during the entire Promotion Period, on a first-come first-served basis, while stocks last. Each Customer shall only be eligible to redeem 1 Jollibee Voucher per day.
8. The Customer may redeem (1) pcs of Original Chickenjoy using the Jollibee Voucher with a min. spend of \$13 using Qualified NETS Bank Cards or Qualified QR Applications at selected Jollibee’s Participating Outlets (“**Jollibee Redemption**”) Further terms and conditions governing the validity and usage of Jollibee Voucher (set out in **Part A** below) (“**Jollibee Voucher T&C**”) apply.

9. The Jollibee Redemptions are only available at manned cashier counters at Jollibee outlets as set out in Jollibee Voucher T&C and not valid for online ordering or self-service kiosk purchase.

BATA Vouchers are only applicable for use on regular-priced items from Participating Brands. Further terms and conditions governing the validity and usage of BATA Voucher (set out in **Part B** below) (“**BATA Voucher T&C**”) apply.
13. The BATA Redemptions are only available at manned cashier counters at BATA outlets as set out in BATA Voucher T&C and not valid for online ordering or self-service kiosk purchase.

14. This Promotion is only available for purchases at manned cashier counter at Participating Outlets and not valid for online ordering or self-service kiosk purchase.
15. This Promotion is not valid in conjunction with other promotions, all promotions are mutually exclusive.

17. If any Qualifying Transaction is cancelled or reversed during the Promotion Period, the Customer will not be considered to have met the Qualifying Transaction. In this event, the Customer shall reimburse NETS for the retail costs of the Redemption redeemed, when requested by NETS.
